

# 'Cajun Hell' documentary in post production, screening in VP planned

"Cajun Hell" is the product of San Francisco's Eric Dunn, who heard of the Ville Platte 90s punk rock band Mystic Fix several years

ago. Dunn, who has worked as a music video director, embarked on the journey of making his first film when he heard about the tragic death of Mystic Fix's Criss Drunk. At [www.cajunhell.com](http://www.cajunhell.com), the film is summed up as "a look back on the life and tragic death of struggling and influential musician Criss Drunk and his refusal to leave Louisiana's Cajun Country for a better shot at success in a more populated and open-minded area of the country. The film follows Drunk's story as he chases his dreams despite constant obstacles, jump-starts the Louisiana punk scene, and influencing many peers along the way to pick up instruments and start

playing music." A trailer for the film can also be viewed at the website. (*Warning: The trailer contains some foul language.*) Dunn said a test screening was held July 11, at McNeese State University and he is currently editing the film. He hopes to do more shooting if he can

get the funds together. The film, which began shooting in November 2009, contains many interviews with Ville Platte residents who fondly remember Mystic Fix or were part of the group. In addition, the film also focuses on life in Cajun country and the difficulty the punk rock band faced in trying to make a name for themselves. ## Wine tasting fund raiser scheduled

## Day of remembrance held in St. Martinville

The Acadian Memorial in St. Martinville observed a "Day of Remembrance" July 28, marking the seventh anniversary of the signing of an official apology by Queen Elizabeth of England for the exile of Acadians from eastern Canada starting in 1755.

The remembrance included a Catholic mass in French, followed by a candle light procession to the memorial's Deportation Cross, based on the original cross in Canada.

more than the month before, according to commission auditor Winston Ardoin.

errors occur when residents of incorporated areas of the parish are incorrectly placed in rural areas, for example.

He said that since incorporating in 2003, Pine Prairie Energy has paid \$9.5 million in taxes compared to the \$5 million the company estimated it would pay in taxes by now. Ardoin reported that \$1.2 million of the \$9.5 million was assessed as penalties and interest for unpaid taxes.

Although there are "a tremendous amount of errors," in determining where the taxes should go, "It's not as bad as it once was," Ardoin said.

Ardoin reported to the commission that he is continuing to correct a problem involving motor vehicle taxes which are correctly being collected, but are being deposited into the wrong accounts.

He said he used to inform the state of needed corrections to the state's tax deposits but that the state corrected a small percentage of deposits. "I was just wasting my time," he said.

He said the problem originates with a computer program used by the Louisiana Office of Motor Vehicles to determine residency. The

Ardoin said he has used parish fire and police department resources, as well as voter registration lists, to develop a computerized database connecting addresses with tax jurisdictions. He said car dealers and others have relied on to pay taxes to the correct rural or municipal jurisdictions.
